Meeting Called to Order: at 19:00 by Clerk Mosher. Mosher offers to chair meeting in absence of Supervisor Seguin. Draeger supports. All in favor, none opposed.

Announcement: The board has just been informed Supervisor Ron Seguin passed away last night, he will be deeply missed, and his years of service to the community greatly appreciated and valued.

Agenda: Mosher requests to add item 10b, Blight Ordinance. Draeger motions to approve with addition, Mosher seconds, no opposition, motion carries.

Public Comment: Magnolia Cooper: voices concerns over zoning violation and inability to obtain building permit. Board directs Ms. Cooper to JPC. Tim Ranville comments people do not report blight complaint because they have to put name of reporter.

Guests:

- a. Greg Kraft: Zoning paperwork missing from when S. Greene was Zoning admin. States multiple permits and associated paperwork are missing and are still needed.

County Commissioner's Report: Verbal report given, Headlee did not pass, will be a new millage on November ballot as well as animal control, drug enforcement officer. No action.

Meeting Minutes: Election Commission minutes motion to approve by Draeger, second by Mosher. No opposition, motion carries.

Clerk's Report: Election completed successfully, still need election inspectors for November.

Financial Report: July 2026 Financial report provided. Brief discussion. Motion by Mosher, second by Besey to approve as presented. No opposition, motion carries.

Treasurer's Report: Still working on getting access to online accounts through bank.

Supervisor's Report: Board will accept letters of interest and will appoint Supervisor to complete the term. Call for letters of interest will be posted on the web page.

Campground Report: Camping volume is low, trash emptied, Besey removed several large items of rubbish that were placed next to dumpster as well as several items that were abandoned on lot 11. These items would not fit in dumpster.

Blight: No change.

Building Committee: Mosher left messages with 2 architectural companies asking for return call, no response.

Joint Planning Commission Update: Extension of contract for Networks Northwest, Committee for ordinance review appointed.

Zoning Administrator Report: Written report provided and reviewed, no action.

Website Committee: activities paused due to audit and election preparation.

Library: report available to review via email.
